# RELEASE AND INDEMNITY AGREEMENT

Whereas, the undersigned has voluntarily elected to have a Beak n Wings representative enter your premises' for bird grooming

Whereas, the undersigned understands there could be risks associated to grooming a birds, wings, nails, and beak.

1. Assume full responsibility for any personal injury or any damages to said bird or property which may occur, directly or indirectly. While grooming your birds, or while accompanying any member of the Beak n Wings while in the performance of their duties; excepting injury or damage of property which may arise out of the negligent or intentional acts or omissions of Beak n Wings and its members or agents.

2. Fully and forever release and discharge Beak n Wings, its agents and members, from any and all claims, demands, damages, rights of actions, or causes of actions, present or future, whether the same be known, anticipated or unanticipated, resulting from arising out of the undersigned being in, on, or about any such Beak n Wings vehicle, or at any or all of the premises or places aforesaid; or while accompanying any member of the Beak n Wings as aforesaid; excepting those matters which may arise out of the negligent or intentional acts of omissions of Beak n Wings and its members or agents.

3. To the extent not covered by insurance, indemnify and hold harmless the Beak n Wings, its agents and members, for acts or conduct of the undersigned of whatever kind or nature whatsoever, while in, on, or about any such Beak n Wings grooming tools, or at any or all the premises and places aforesaid; or while accompanying any such members as aforesaid; excepting those negligent or intentional acts or omissions of Beak n Wings and its agents, members.

4. Agree to defend and to pay any attorneys' fees as a result of any action brought by or against the Beak n Wings, its agents and members, for any acts or conduct of the undersigned of whatever kind or nature whatsoever, while in, on, or about any such Beak n Wings grooming tools, or at any or all of the premises or places aforesaid, or while accompanying any such member as aforesaid; and

5. Agree that it is the intent of the undersigned that this Release and Indemnity Agreement be in full force and effect at any time after the execution hereof.
